Not everyone will find themselves being employed by others. Some will employ themselves by venturing into a business. Venturing into a business does not necessarily require one to first retire from formal employment or reach a certain age in order to start it. One can start a business at any stage. While some businesses flourish, others fail on the way. As such, there is a need to have certain qualities in order to successfully run a business. This discussion therefore looks at the qualities of a successful business person.

Firstly, one needs to be willing to take moderate risks. Business is about taking risks. If you cannot take risks you cannot grow in business. For example, some people say they cannot run a transportation business because they fear that their vehicles will get involved in an accident which can lead to a big loss. This is retrogressive thinking. A good business person is always positive about the future. In this case, he or she will definitely buy a pick up and assure himself or herself that he or she will succeed in such a venture. Such a spirit is what is required in business.

Secondly, a business person should have the ability to identity and explore opportunities in his or her environment. It is recommended to think of new ways of investing and trying those avenues. For instance, if you sell vegetables, you can also

sell tomatoes because it is likely that the one who wants vegetables would look for tomatoes. Or, while selling sugarcane, you can also sell boiled eggs at the bus depot. This is what is called diversification.

Thirdly, perseverance is another quality one needs to have in business. Most people think that if they start a business today, it will boom right away within a short space of time. You need to realise that there are also some ups and downs in business. Even if it means people making bad comments about your business, you do not have to give up. For example, if your business is not making profits, you should never give up but rather find a better way of boosting it in order to make profits.

Finally, a successful business person should be flexible to the demands of his or her customers. A good business person should listen and take note of what his or her customers demand. For example, if you are running a retail shop and your customers have asked for a repack of sugar into small quantities such as one kilogram to be in five hundred-gram packs or a loaf of bread into half a loaf, you should listen and offer them those products.

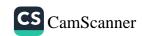
Doing well in business does not just come on a silver platter. It takes commitment and perseverance on the part of the business person. The business person should try one thing or another until success is realised.
